PEPSA SCHOLARSHIP PROGRAM

Eligibility

- Applicant must be a current PEPSA Member in good standing or a spouse, child, grandchild, or stepchild of a PEPSA Member in good standing.
- Applicant must be planning to attend, or already enrolled in an undergraduate program at an accredited educational institution, a public or private college, university, community, or technical college.
- Members of PEPSA's Board of Directors or their children or grandchildren shall not be eligible.

Application Requirements

Applicants must submit:

- Original Signed Application including PEPSA member's name of parents/guardian.
- Three (3) Character References, including one by a public employee who is not a relative.
- Most recent Official High School/College transcript with G.P.A.
- Typed essay on "The Role & Value of Public Employees in our Society".
- Typed Statement of Financial Need.

Judging

Applicants will be awarded a maximum of 100 points in four categories:

- Scholarship Standing (GPA and/or SAT or ACT scores) - 25 points
- Extracurricular, volunteer activities, leadership and community involvement - 25 points
- Essay - 25 points
- Character References - 25 points

All scholarship applications become the exclusive property of PEPSA. This decision of the selection committee is final, and not subject to review.
